

Advantage Member Scheme for Schools and Language Centres

Terms and Conditions 2018 - 2019

General Conditions

1. These terms and conditions define the rules, scope and conditions of participation in the examinations member scheme offered by the British Council, hereafter referred to as “**Advantage**”.
2. The **Advantage** member scheme is fully owned and operated by the British Council.
3. The **Advantage** member scheme recognises schools and language centres which register candidates through a group entry form **and collective payment** for one or more of the **Cambridge English Qualifications**.
4. Schools and language centres that join the **Advantage** member scheme will have access to benefits for either Basic membership holders or Premium membership holders depending on the number of candidates registered with us during one academic year.
5. Benefits not used by the end of the academic year will expire and cannot be carried forward to the following year.

Rules for participation

1. **Advantage** is open to any school or language centre that **registered** candidates for **Cambridge English Qualifications** with us in the 2017-2018 academic year and new schools and language centres who would like to partner with us in the 2018-2019 academic year.
2. Your membership will be activated automatically when you send in your block entry registration form **and collective payment** as from **01 September 2018**.
3. Membership is automatically extended and is valid until cancellation.
4. Members have the right to terminate membership at any point. This should be done in writing to the local **Advantage coordinator**. Membership will cease from the moment the British Council receives written notification requesting this.
6. From the moment membership is terminated, all entitlement to benefits of the scheme will cease and members are obliged to remove the **Advantage** logo from their website and return the **Advantage** membership plaque and refrain from referring to the **Advantage** programme from thereon.
7. Membership will not be extended to the following year in the event a member centre has not registered any candidates in the current year.

Termination and amendments

The British Council reserves the right to introduce amendments to these regulations and to review the benefits each year. The **Advantage** member scheme may be terminated at any time with 3 months’ notice.
